

TERMS AND CONDITIONS OF THE GOT PARIS Cosplay Contest

The purpose of this document is to establish the basis of the GOT PARIS Cosplay Contest that is promoted and carried out within the framework of the exhibition Game of Thrones: The Touring Exhibition in Paris.

1) COMPANY ORGANIZING THE PROMOTION. Encore Productions, 6 rue du Mont Thabor, 75001 Paris – RCS Paris B 341 554 269

2) TERRITORY SCOPE. The GOT PARIS Cosplay Contest will be held on Saturday, July 21st at the “Game of Thrones: The Touring Exhibition”, located at Paris Expo / Porte de Versailles, Pavillon 2.1, Place de la Porte de Versailles, 75015 Paris, under the conditions established in these rules of participation.

3) FORM OF PARTICIPATION. Attendees who wish to participate must present themselves at the exhibition on Saturday, July 21st, 2018 between 2:00 pm to 4:00 pm, dressed as a character from the HBO series “Game of Thrones”. All those persons dressed, as his or her favorite series character will gain free entry to the exhibition on July 21st, 2018. Participants must present themselves upon arrival at the welcome desk to register for the Contest by filling out an entry form. All registered participants will be judged on 40% authenticity and 60% creativity by a 3-person panel of judges. Only people over 18 years old may participate in this Contest. Employees and consultants of Encore Productions, Home Box Office, Inc., GES Events, and each of their respective affiliates, subsidiaries, divisions, and advertising and promotional agencies and their respective officers, directors and agents (collectively, the “Sweepstakes Entities”) and the immediate family members and persons living in the same household of each are not eligible to enter or win.

4) PROMOTIONAL PERIOD. The participants can only register at the exhibition between 2:00 and 4:00 pm on July 21st.

5) WINNER SELECTION. On Saturday July 21st at 4:00 pm, the panel of judges will choose the 5 finalists winning cosplay participant. The decision of the panel will be irrevocable.

6) COMMUNICATION OF THE WINNERS. On Saturday July 21st, 2018 at 4:20 pm, the panel of judges will announce the 5 finalists and at 4:30 pm the winner of Best Cosplay. Participants should be present in the lobby area of the exhibition between 4:15 and 4:40 for the announcement of finalists and awarding of winner of Best Cosplay.

7) PRIZE. The finalists and the winner of the Contest will receive as a prize an official Game of Thrones pack including a selection of GOT DVD sets and gift cards for the retail shop of Game of Thrones: The Touring Exhibition.

8) IN-PERSON PARTICIPATION. The organization reserves the right to exclude any participant from the Contest if there is any indication of misbehavior, improper conduct, fraud or inappropriate acts before or during participant’s presence on site. Likewise, the organization reserves the right to withdraw the participation of any contestant in the case of the use of fraudulent mechanisms to participate in this Contest (including but not limited to false identity, wrong age, address, ...). The organizing company reserves the right to request

official documents to prove the identity of the participants in the case of them being winners.

9) PERSONAL DATA. In compliance with the provisions of Law No. 2018-493 of 20 June 2018 on the protection of personal data and the Regulation on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC (« General Data Protection Regulation ») Encore Productions with registered office at 6 rue du Mont-Thabor, 75001 Paris, informs you that you give your express consent for the personal data you provide us with, in relation to the Contest, be incorporated into a file owned by this company with the purpose of carrying out: a) your participation in the promotion, b) the management and delivery of the prize, in the event that you are awarded it, c) compliance with any tax or other obligations that may apply in relation to the promotion.
